### **Pmm Wing Service engine Warranty: 2 Years, Unlimited Hours to TBO**

Subject to the limitations and conditions set forth in this warranty, Pmm Wing Service warrants its overhauled and experimental aircraft engines, exclusive of engine accessory components noted below, are free from defects in material and workmanship, under normal use and service, for a period of 2 Years from delivery or to manufacturers TBO of operation, whichever event will occur first. Pmm Wing Service warrants the engine accessory components installed by Pmm Wing Service, including magneto's, starter, alternator (or generator), fuel pump, fuel injector and carburetor, are free from defects in material and workmanship, under normal use and service, for a period of one year from delivery. Customer supplied parts or accessories the customer requests be re-used will not be warranted.

Pmm Wing Service's obligation under this warranty is limited to the repair or replacement, at their option, of any part, component, or engine which, in its opinion, is defective, and which has been returned to its facility, transportation prepaid. Pmm Wing Service assumes no obligation for work accomplished at a facility other than its own unless prior written authorization is given by it. Pmm Wing Service reserves the right to furnish any parts and/or components required. Applicable labor reimbursement is per manufacturer's flat rate allowance.

After the initial warranty period, Pmm Wing Service will not assume any responsibility for the repair or replacement of engine or component. Pmm Wing Service will be relieved of all obligations and liability under this warranty if the engine, or accessory component, have been improperly installed, adjusted, stored, handled, repaired, altered, or operated contrary to the aircraft flight manual, current manufacturer's, or Pmm Wing Service recommendations. This warranty will not apply to engines or accessories subject to misuse, neglect, accident, corrosion, or lack of preventive maintenance as prescribed by the manufacturer.

**This warranty is null and void if the engine has run on fuel that is not approved by the manufacturer.**

Warranties will not be granted for trouble-shooting, or removal and installation of engines, or components or accessories, for normal routine maintenance, inspections, or adjustments. Costs associated with technical assistance or instructions provided by Pmm Wing Service, including Parts, labor, and transportation of product or components sent to Pmm Wing Service for trouble-shooting, are not covered by warranty absent a warranty defect. A replacement product/part assumes the remaining warranty of the original product. Pmm Wing Service shall not be responsible for any down time or travel costs, including incidental expenses associated with loss of use due to warranty conditions.

This warranty is a warranty to repair or replace and not a warranty of the condition or future performance of the products which it covers. There are no other warranties, expressed or implied, specifically, but without limitation, there are no implied warranties of merchantability, fitness or otherwise. In no event will Pmm Wing Service be responsible for any incidental, indirect, special, consequential, multiple or punitive damages arising out of any defect in any engine or part, arising out of the failure of any engine or part to operate properly, or arising out of any breach of the warranty made herein. This includes, without limitation, any damages for diminution of market value, loss of use or loss of profits or revenues, and any damages claimed under the theories of negligence or strict liability in tort. No person is authorized to give any other warranty or to assume any additional obligation or liability on behalf of Pmm Wing Service. The construction and interpretation of this warranty shall be governed by the laws of Belgium in the court of Hasselt.
